- **3.Tender opening:** Tenders will be received only upto the date and time prescribed in para(1). All the tender received will be opened at **14:00 Hrs. on 19.01.2021** by the Disposal committee at the Office of the Principal Commissioner, Central Goods & Services Tax, Ranchi, Central Revenue Building, 5A-main Road, Ranchi- 834 001 in the presence of the tenderers or their authorized representatives, who choose to be present. In case of participation by any representative, the required authorization letter issued by the tenderer should be submitted to the office before the date of opening of tender in a separate cover. This letter of authorization must not be enclosed with the sealed tender. Only permitted representative will be allowed to participate in the tender.
- 4. The financial bid should be quoted both in figures and word and overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tenderer.
- 5. Department reserves the right to accept or reject any/ all quotations without assigning any reason whatsoever.
- 6.Payment: In the event of acceptance of tender, the successful bidder will be required to deposit full amount in shape of Demand Draft in favour of " Chief Accounts Officer, Ranchi" within 03 days from the issue of order, failing which the sale order shall be cancelled.
- 7. The items will be released for delivery to the successful tenderer only after the full payment of the entire bid amount including applicable taxes.(if any)
- 8. Loss or damage: Once the tender is finalized and the entire bid amount collected, and delivery authorization issued, this office will not be responsible either for safe custody or for any loss or damage of the items beyond 24 hours of finalization of tender.
